## Storage

Store at +4°C or at -20°C if preferred.

Storage in frost-free freezers is not recommended.

This product should be stored undiluted. Avoid repeated freezing and thawing as this may denature the antibody. Should this product contain a precipitate we recommend microcentrifugation before use. **Shelf Life:** 18 months from date of dispatch.
